Title:

Consideration of Liquor License Application: Clare Abel, "Wal-Mart Supercenter #4252", to be located between Huntington Drive and Highway 40, Series 09, New

License.

#### **Recommended Action:**

Open the public hearing. Receive citizen input. Close the public hearing.

The City Council has the option to:

(1) Forward the application to the State with a recommendation for approval:

(2) Forward the application to the State with no recommendation; or

(3) Forward the application to the State with a recommendation for denial based on the testimony received at the public hearing and/or other factors.

#### **ACTION SUMMARY:**

The Council's action will depend on testimony received at the public hearing, to be conducted under the attached Liquor License Application Hearing Procedures.

#### DISCUSSION:

#### Background/History:

- An application for a new Series 09 liquor license was received from Clare Abel on behalf of Wal-Mart Supercenter #4252, whose location will be between Highway 40 and Huntington Dr. (Map is attached.)
- A background investigation performed by Sgt. Walter Miller of the Flagstaff Police Department resulted in a recommendation for approval.
- A background investigation was performed by Travis Hough Jr., Code Compliance Officer, who stated the property is located in the Urban Commercial District which allows liquor sales. As of yet, the business has not submitted plans for review.
- Sales tax and licensing information was reviewed by Steve Shafer, Tax, Licensing & Revenue Administrator, who stated that the proposed business has not yet been built so a City sales tax license has not been issued for that location. Based on the tax reporting history of Wal-Mart, Inc., no problems are anticipated.



#### **Key Considerations:**

- Because the application is for a new license, consideration may be given to the location and to the applicant's personal qualifications.
- A Series 09 license allows a spirituous liquor store retailer to sell all spirituous liquors, only in the original unbroken package, to be taken away from the retailer and consumed off the premises.
- The deadline for issuing a recommendation on this application is July 1, 2008.

#### **Community Benefits and Considerations:**

- This business will contribute to the tax base of the community.
- We are not aware of any other relevant considerations.

#### **Community Involvement:**

- The application was properly posted on May 12, 2008.
- No written protests have been received to date.

#### Financial Implications:

• There is no budgetary impact to the City of Flagstaff.

#### **Options and Alternatives:**

- (1) Table the item if additional information or time is needed.
- (2) Make no recommendation.
- (3) Forward the application to the State with a recommendation for approval.
- (4) Forward the application to the State with a recommendation for denial, stating the reasons for such recommendation.

# **Liquor License Application Hearing Procedures**

- 1. When the matter is reached at the Council meeting, the presiding officer will accept a motion to open the public hearing on the item.
- 2. The presiding officer will request that the Applicant come forward to address the Council regarding the application in a presentation not exceeding ten (10) minutes. Council may question the Applicant regarding the testimony or other evidence provided by the Applicant.
- 3. The presiding officer will then ask whether City staff have information to present to the Council regarding the application. Staff should come forward at this point and present information to the Council in a presentation not exceeding ten (10) minutes. Council may question City staff regarding the testimony or other evidence provided by City staff.
- 4. Other parties, if any, may then testify, limited to three (3) minutes per person. Council may question these parties regarding the testimony they present to the Council.
- 5. The Applicant may make a concise closing statement to the Council, limited to five (5) minutes. During this statement, Council may ask additional questions of the Applicant.
- 6. City staff may make a concise closing statement to the Council, limited to five (5) minutes. During this statement, Council may ask additional questions of City Staff.
- 7. By motion, Council will then close the public hearing.
- 8. By motion, the Council will then vote to forward the application to the State with a recommendation of approval, disapproval, or shall vote to forward with no recommendation.

## License Types: Series 09 Liquor Store License (All spirituous liquors)

Transferable (From person to person and/or location to location within the same county only)

Off-sale retail privileges

Note: Terms in BOLD CAPITALS are defined in the glossary.

#### **PURPOSE:**

Allows a spirituous liquor store retailer to sell all spirituous liquors, only in the original unbroken package, to be taken away from the premises of the retailer and consumed off the premises.

#### ADDITIONAL RIGHTS AND RESPONSIBILITIES:

A retailer with off-sale privileges may deliver spirituous liquor off of the licensed premises in connection with a retail sale. Payment must be made no later than the time of **DELIVERY**. The retailer must complete a Department approved "Record of Delivery" form for each spirituous liquor retail delivery.

On any original applications, new managers and/or the person responsible for the day-to-day operations must attend a basic and management training class.

A licensee acting as a **RETAIL AGENT**, authorized to purchase and accept delivery of spirituous liquor by other licensees, must receive a certificate of registration from the Department.

A **PREGNANCY WARNING SIGN** for pregnant women consuming spirituous liquor must be posted within twenty (20) feet of the cash register or behind the bar.


