Chair Ryan called the meeting to order at 8:12 a.m.

I. PRELIMINARY GENERAL BUSINESS

C. APPROVAL of MINUTES.

Ms. Evans made a motion to approve the Minutes of November 28, 2012 and Mr. Oravits seconded, motion passed unanimously.

II. OLD BUSINESS (Continued, postponed, and tabled items.)

1. Legislative and Regulatory Update and Review

Mr. Wessel stated that Kevin Adam was unable to attend to give the update and outlined the RTAC handout. He stated that it was the Board's responsibility to push for a stop on raids of Highway User Revenue Funds, as the funding was needed to prevent and repair infrastructure decline. The Board agreed to email an informational video to educate the appropriate boards, committees, and persons. There was discussion only.

2. Draft FY 2014 Unified Planning Work Program and Budget

Mr. Wessel stated that it was time to update the Regional Transportation Plan, create a better access management plan, and begin a sidewalk program. Milton is being focused on in a transit study as a potential transit hub, which Mr. Wessel is using a micro simulation model to study. He requested that the Board approve a shift of \$45,000 in the TIP from Adaptive Control Signal Technology funds to expand the model, as the ACST project has been delayed. He confirmed that the project would still have enough funds to begin the project planning phase, especially if the FMPO partnered with ADOT to implement signal control in certain corridors. The Board directed staff to reflect the shift of \$45,000 from the ACST project to the Milton Road study. There was discussion only.

III. NEW BUSINESS (Continued, postponed, and tabled items.)

3. History of Interstate-11 and Feasibility Study Status

Mr. Wessel overviewed the history of I-11, stating that its purpose as a connecting corridor between Phoenix and Las Vegas would be more useful in the future if one of the cities shifted from being a consumer market to production and possibly distribution. The Board discussed the I-11's funding, which is speculated to potentially come from private sectors which would collect tolls, and the impact the interstate would have on Flagstaff, which might be beneficial to some but detrimental to others depending on the access to Phoenix and Las Vegas markets. There was discussion only, and a commitment to leave this as a standing item on the agenda.

4. Regional Plan 2012 Road Network

Mr. Wessel introduced the topic, reviewing the previous work done to the network's plans by a few committees, resulting in the current plan of a hybrid network with some wider roads, more connections, and more incorporation of alternative modes of travel. The Board discussed the need to ease congestion versus the needs to encourage potential consumers to slow down and visit in certain areas, with attention given to network treatments in the north Fourth Street area. Ms. Evans reminded the Board to consider the neighborhoods affected by widening roads or speeding traffic, and recommended an economic study on the Lone Tree overpass. There was discussion only and general agreement that the network could be presented for public comment.
