Commercial enplanements, aviation activity and sale of fuel (*Barney Helmick*)

Mr. Helmick reviewed the following for the Commission:

Commercial Enplanements: Total enplanements are up over last month. The weather was corporative for flights.

Total Operations: Operations have been consistently increasing due to general aviation, and military use.

Fuel sales: Fuel sales are above last month's numbers. The numbers have increased over last year, and looking up toward the next several months.

Chair Keegan informed the Commission that this year our Military Appreciation Day will be May 17, 2014. The approval process is in place and we are waiting to hear back from several military bases. 2. City of Flagstaff 2015 Budget (*Barney Helmick*)

Mr. Helmick shared with the Commission the 2015 Budget for the Airport. He explained the narratives, grants and sections. Mr. Helmick also provided segments under General Administration and Maintenance expenditures.

3. Update on the State Legislative Bill (*Barney Helmick*)

Mr. Helmick spoke about the SB1174 Bill; set in motion to reduce registration costs for larger aircraft and increase fuel taxes. This Bill did not get passed.
