II. STAFF REPORTS

Commercial enplanements, aviation activity and sale of fuel (*Barney Helmick*) Mr. Helmick reviewed the following for the Commission:

Commercial Enplanements: Total enplanements for January continue the trend in numbers growing; we are experiencing an increase of almost 500 passengers per month.

Total Operations: Operations were slightly less than last year. However, operations exceeded last month numbers.

Fuel sales: Fuel sales are up from last month and last year, just slightly less than a 12% increase from last year.

1. New Commissioner/Staff Introductions (Barney Helmick)

Mr. Helmick introduced new staff and Commissioners shared about themselves along with their interests on being part of the Airport Commission.

2. Commission Appointments (Barney Helmick)

Commissioner Hagan moved to appoint Commissioner Shankland as the current Chair. Commissioner Brace seconded Shankland the motion; the motion passed unanimously.

3. Sustainability Plan (*Barney Helmick*)

Mr. Helmick advised the Commission on the Sustainability Plan for the Airport. He spoke about the contracted advisors and the opportunities for the Commission and the Community to become involved.

4. State Aviation Fund (Barney Helmick)

Mr. Helmick explained that the State Aviation Fund needs to be closely watched and protected. The allocated funds that are being swept are needed for Runway maintenance and other high safety priorities.

5. Second Airline Update (Barney Helmick)

Mr. Helmick has several meetings scheduled this year, which will allow him the opportunity to speak face to face with the Airlines. He is hopeful that the market will take notice of the positive numbers KFLG Flagstaff Airport has been generating over the past year.

V. FIXED BASE OPERATOR REPORT

1. General aviation issues, fuel sales and business report. (Orville Wiseman)

Mr. Wiseman advised the Commission that the F 2014 Bel numbers Overe the third best in 16 years. The FBO also had a great response from the Super bowl. Several corporate jets and many general aviation aircraft added to the positive fuel numbers for the month. The FBO is continually gracious in giving to the community and will be participating in a Fly-in, coming August 22, 2015.

Chairman Shankland wished to thank Past Chair Keegan for his service to the community and is hopeful that he can live up to Mr. Keegan's legacy.

2. Commissioners

Commissioner McDaniel informed the commission of a Lincoln Dinner that still has opportunities/space to meet with the Governor.
