## TO BEGIN THE PROCESS

- ★ IF you plan to receive or expend, *in any combination*, more than \$500 during the election cycle, you must file a Statement of Organization. The election cycle is 01/01/19—12/31/20.
- ★ Be sure to maintain all records because IF you go over the \$500 limit during the election cycle, you must file a Statement of Organization within 10 days.

## FILING YOUR PAPERS

You must file the following documents with the City Clerk's Office **between 03/09/20 and 04/06/20**:

- ✓ Nonpartisan Nomination Paper Declaration of Qualification
- ✓ Nonpartisan Nomination Petitions signed by **at least 1,045 and no more than 2,089** City of Flagstaff registered voters
- ✓ Financial Disclosure Statement
