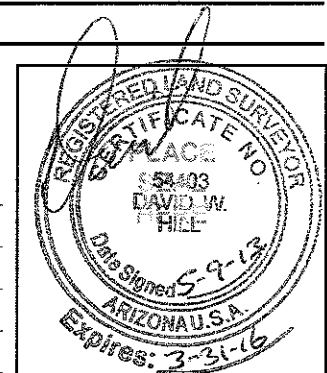

This building has 4 visible air vents. The vents do not appear to be FEMA approved flood vents. The crawlspace was not accessible. 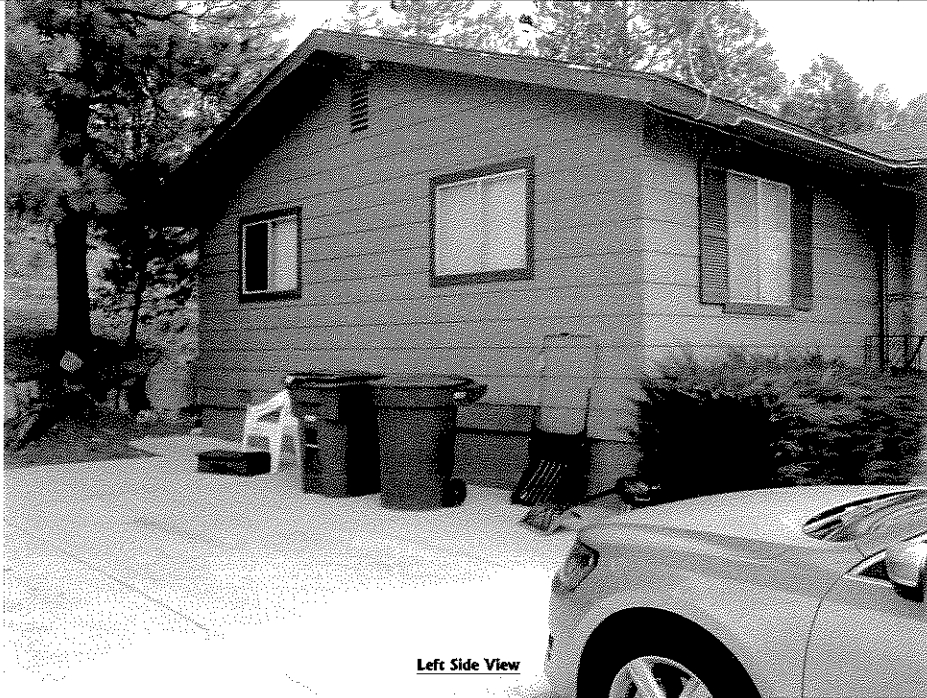

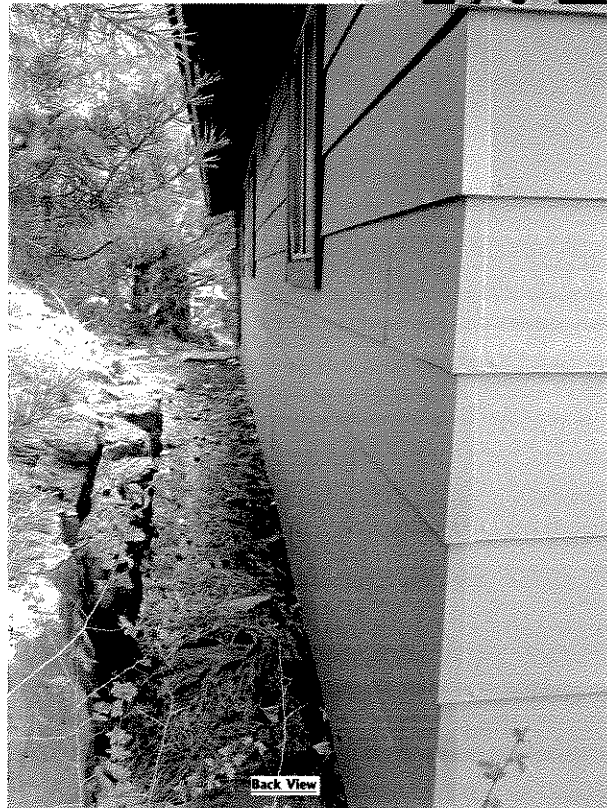
