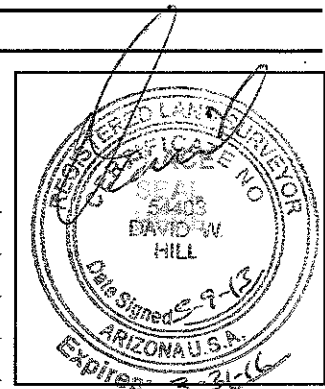



Comments The BFE is calculated using the flood profile at the station adjacent to the westerly corner of the building where it would be at its highest elevation along the building. This building has 8 visible air vents. The vents do not appear to be FEMA approved flood vents. The crawlspace was not accessible. Item C2 a) is the top of the crawlspace floor measured at the lowest adjacent (finished) exterior grade next to the structure. Item C2 b) is the finished floor of the building.
