Small Business Waste Program (SBWP)

The SBWP provides a safe, affordable and ecologically appropriate option for small businesses to dispose of hazardous waste in accordance with Local,

State, and Federal regulations

Requirements

To utilize the SBWP, businesses must qualify as a Very Small Quantity Generator as defined by the following criteria:

- Accumulate 1 kg (2.2 lbs.) or less of acute hazardous waste in a calendar month
- Accumulate 100 kg (220 lbs.) or less of non-acute hazardous waste in a calendar month
- Accumulate no more than 1000 kg (2200 lbs.) of non-acute hazardous waste at any given time

After determining if your business qualifies as a VSQG, you must:

- Call the HPC at (928) 213-2159, or send an email to hpc@flagstaffaz.gov to set up an appointment
- Give a detailed inventory of your hazardous waste and any SDS's that pertain to your drop-off
- On the day of your appointment, safely and securely transport your hazardous waste to the HPC with proper labeling and containment
- NOTE: The HPC reserves the right to refuse any waste not declared at the time the appointment was scheduled.
