#### **RE: Section 8 Waiting List Closure and Online Application**

**As of April 9, 2020, the Section 8 waiting list is closed to new applications. As was posted, we reached 1,500 applicants and subsequently closed.**

If you wish to apply for Low-Income Public Housing, you can access the online pre-application at <https://flagaz.myhousing.com>. All applications for Public Housing must be filed electronically. Applicants are not required to come to the Housing Authority office to apply. (See also the above office restrictions.) Applicants can use any computer, tablet, or smart phone with internet access to apply, including free computers at public libraries, other social service agencies, or at the City of Flagstaff Housing Authority Office located at 3481 N. Fanning Dr. Flagstaff, AZ 86004 during typical business hours.

If you are unable to file your application due to disability, please contact us as soon as possible to request a reasonable accommodation. You may write to us or come in to the office at 3481 N Fanning Drive, Flagstaff, Arizona 86004. You can also email us at [housing@flagstaffaz.gov](mailto:housing@flagstaffaz.gov). The City of Flagstaff Housing Authority will use the timestamp associated with this communication to establish your waiting list position. About 24 hours after you apply, applicants can register using their confirmation number and update their file at <https://flagaz.myhousing.com/Account/Login>. While email is our primary means of communicating to applicants, applicants will be contacted at their mailing address on file before being removed if they fail to respond to online notices.

Clark Homes continues to accept only paper applications at this time. You can apply in person, Monday through Thursday, 8:00 am to 12:00 pm and 1:00 pm to 6:00 pm, or on Friday, 8:00 am to 12:00 pm.
